

# 2012 Flint/Mid-Michigan entry form --- Sanction #11577

- When: April 21, 2012 - Check in 10:30 (all competitors), Prejudging 12:00, Evening show 7:00
- Where: Flushing High School, 5039 Deland, Flushing MI 48433
- Eligibility: Mid-Michigan is open to all N.P.C. registered athletes. N.P.C cards are \$100 and may be purchased, check or money order, the day of the show. Local division is open to N.P.C registered athletes residing in Genesee or Lapeer County.
- Awards: Top Five in each division will receive an award.
- Divisions: Local men, local women, open men – bantam (143 ¼ & under), (light 143 ½ -154 ¼), middle (154 ½ - 176 ¼), light heavy (176 ½ - 198 ¼), heavy (198 ½ & over). Open women, master's women 35 - 39, master's men 40 – 49, grand master's men 50 & over, teen men 16 & over, wheelchair men, wheelchair women, fitness women, bikini women, bikini master's 35 & over, figure women, figure master's 35 - 39, figure grand master's 40 & over, teen 16 -19, physique men, physique women. All divisions depend on the number of pre-entries
- Music: All bodybuilding, physique, & fitness competitors must supply their own music, labeled with name, and it should be the only song on a CD. Music must be No longer than 90 seconds for bodybuilding & 2 minutes for fitness. Music will be collected at check in. Crossovers will pose only once. Promoter reserves the right to cut inappropriate music.
- Entry Fee: \$80.00 all divisions. Crossovers are an additional \$50.00 per division. Entry fee must be postmarked by April 1 to avoid late fee. After April 1 all divisions will be \$125.00 (crossovers \$80.00 per division).
- Drug Testing: The bodybuilding divisions will be drug tested in accordance with NPC guidelines. The urinalysis drug test is sent to an International Olympic Committee accredited Lab. Testing is done at prejudging.
- Tickets: Prejudging is \$15.00. Evening show VIP is \$40.00 reserved \$30.00 & \$20.00
